## **GOD'S ANSWER IN JESUS**

Colossians 2:13 – 15 (Amplified)

*When you were dead in your sins and in the uncircumcision of your flesh (worldliness, manner of life), God made you alive together with Christ, having [freely] forgiven us all our sins,<sup>14</sup> having canceled out the [g]certificate of debt consisting of [h]legal demands [which were in force] against us and which were hostile to us. And this certificate He has*

*set aside and completely removed by nailing it to the cross. <sup>15</sup>When He had disarmed the rulers and authorities [those supernatural forces of evil operating against us], He made a public example of them [exhibiting them as captives in His triumphal procession], having triumphed over them through <sup>[1]</sup>the cross.*

IT IS OUR RESPONSIBILITY TO ENFORCE CHRIST'S VICTORY IN OUR LIVES.

Jesus did it. We must appropriate it. We do that in God's court. Are you ready?

The court of Heaven is not a model of prayer, it is a dimension of the spiritual realm. In order to deal with the legal issues against us, we are going to have to learn to access that realm and present our cases.
