Exodus 20:4 You shall not make for yourself a carved image—any likeness of anything that is in heaven above, or that is in the earth beneath, or that is in the water under the earth; **you shall not bow down to them nor serve them.** For I, the Lord your God, am a jealous God, **visiting the iniquity of the fathers upon the children** to the third and fourth generations of those who hate Me, but showing mercy to thousands, to those who love Me and keep My commandments.

# THE ANSWER IS FOUND IN THE GOD'S COURTROOM

If you have never heard of the Courts of Heaven, I would strongly recommend purchasing a copy of the book, *Operating in the Courts of Heaven by Robert Henderson.* 

This is an important revelation and teaching that God has been giving to His Body for such a time as this. I believe that INIQUITY is dealt with in the courts of heaven. INIQUITY (with all its spiritual contracts and covenants) gives the enemy legal rights against us in the courts of heaven. The enemy uses these legal rights to delay our destiny.

Legal issues have kept us bound and restrained for too long. It is time to be free. But because they are legal issues, they need to be dealt with legally.

<u>Jesus talks about prayer in the context of a courtroom.</u> Luke 18: 1 – 8

The court of Heaven is not a model of prayer, it is a dimension of the spiritual realm. In order to deal with the legal issues against us, we are going to have to learn to access that realm and present our cases. If you have heard the teachings about the courts of heaven and are wanting to learn how to DO it, then you are in the right place. This is my speciality!

How is INIQUITY a legal issue?

#### How is this INIQUITY removed?

Colossians 2:13 – 15 (Amplified)

When you were dead in your sins and in the uncircumcision of your flesh (worldliness, manner of life), God made you alive together with Christ, having [freely] forgiven us all our sins, having canceled out the certificate of debt consisting of legal demands [which were in force] against us and which were hostile to us. And this certificate He has set aside and completely removed by nailing it to the cross. When He had disarmed the rulers and authorities [those supernatural forces of evil operating against us], He made a public example of them [exhibiting them as captives in His triumphal procession], having triumphed over them through the cross. IT IS OUR RESPONSIBILITY TO ENFORCE CHRIST'S VICTORY IN OUR LIVES.

Jesus did it. We must appropriate it. We do that in God's heavenly courtroom.
